

Ashcreek Playschool Financial Aid Application Form 2021/22

Submit your application to the treasurer (treasurer@ashcreekplayschool.com) by the fifth day of the month preceding the first month in which you would like to receive financial aid. You will be notified of the status of your request before the end of the month in which you applied. The financial aid process is administered by the Financial Aid Committee, which consists of Ashcreek President, Treasurer, and Registrar. Applications and committee business are kept strictly confidential.

Ashcreek Playschool offers tuition assistance to children enrolled in our program based on income level or other financial hardship situations. Financial aid is awarded in the form of discounted tuition and fees and is awarded based on available funds and family needs. In order to determine what financial aid to offer each year, the Financial Aid Committee will consider:

- Available funds and anticipated revenue
- The number of families requesting assistance
- The economic status of the families requesting assistance

To apply for scholarship from Ashcreek Playschool you must submit:

1. Completed application
2. Copy of two most recent pay stubs
3. Most recent tax return (*You may blackout and omit SSN's*)
4. (Optional) Additional documentation of hardship – such as parental job loss, medical bills, etc.

If you cannot provide any of the required documentation you should submit an explanation as to why with your application.
